



## NOTICE OF THE MEETING OF THE COMMISSIONERS' COURT OF GOLIAD COUNTY, TEXAS

Notice is hereby given that a Regular Meeting of the above named Commissioners' Court will be held on the 11<sup>th</sup> day of December, 2018 at 10:00 A.M. in the Commissioners' Courtroom, of the County Courthouse, 127 North Courthouse Square, Goliad County, Texas, at which time the following subjects will be discussed, to wit:

1. **Call the meeting to order**
2. **Invocation**
3. **Pledge of Allegiance to the U.S. Flag / Pledge of Allegiance to the Texas Flag**
4. **Receive public comment on County Operations:** "You may comment on County operations at this time, but let it be known that no action or comments from the Commissioners or the Judge can take place. If your concerns or comments need action; you may have your item placed on the Agenda for the next Commissioners' Court Meeting, so that we can meet the time requirements in the Open Meetings' Act for Posting Notice."
5. **Consent Agenda - Items listed under the Consent Agenda are considered routine and are generally enacted in one motion. The exception to this rule is that a member of the Commissioners' Court may request one or more items to be removed from the consent agenda for a separate discussion and action.**
  - A. Approval of minutes from prior Commissioners' Court meetings
  - B. Action on Goliad County bills
  - C. Approval of Treasurers Report
  - D. Approval of journal entries
  - E. Receive Goliad County Receipt of Donations Report
  - F. Receive Monthly Report from the Goliad Volunteer Fire Department
  - G. Receive Departmental Reports, if any
6. **New Business**
  - A. Discussion/ Action to approve a Budget Amendment of \$30,000.00 to Special Revenue Fund, EMS Donations, to complete the acquisition of an ambulance
  - B. Discussion/ Action to approve an Agreement with the County Information Resources Agency (CIRA) and authorize the County Judge to sign
  - C. Presentation from CU People Inc.
7. **Future Agenda Items**
8. **Public Comment**

Pursuant to G.C. 551.0415 (a), "items of community interest" includes:

  - (1) expressions of thanks, congratulations, or condolence;
  - (2) information regarding holiday schedules;
  - (3) an honorary or salutary recognition of a public official, public employee, or other citizen, except that a discussion regarding a change in the status of a person's public office or public employment is not an honorary or salutary recognition for purposes of this subdivision;
  - (4) a reminder about an upcoming event organized or sponsored by the governing body;
  - (5) information regarding a social, ceremonial, or community event organized or sponsored by an entity other than the governing body that was attended or is scheduled to be attended by a member of the governing body or an official or employee of the political subdivision;
  - (6) announcements involving an imminent threat to the public health and safety of people in the political subdivision that has arisen after the posting of the agenda.
9. **Adjourn**

If, during the course of the meeting, discussions of any item on the agenda should be held in a Closed Meeting, the Commissioners' Court will conduct a Closed Meeting in accordance with the Texas Open

Meeting Act, Texas Government Code, Chapter 551, Subchapters D and E. Before any Closed Meeting is convened, the presiding officer will publicly identify the section or sections of the Act authorizing the Closed Meeting. All final votes, actions or decisions will be taken in Open Meeting.


