## Septic Permitting Process in Goliad County, Texas

- Applications are available on the Goliad County website or in the County Judge's office.
- A licensed site evaluator should perform the mandatory soil identification procedure.
- The appropriate individual should prepare the planning materials. A Professional Design (R.S. or P.E.) is required for proprietary and non-standard systems.
- Submit the completed application and technical information sheet to the County Judge's Office (in the property owner's name), ensuring that all pages are intact. Include the appropriate fee, four (4) copies of the application form, and two (2) copies of the following: 1) planning Materials; 2) site and soil evaluation; 3) accurate directions to the site where the system will be installed.
- Plans and application will be reviewed by the County Environmental Services Officer. Non-standard system plans may be reviewed by TCEQ staff in Austin.
- After approval by the County Environmental Services Officer, an Authorization to Construct will be issued which is valid one year from the date of issuance
- Construction commences. An inspection of the installation is required before covering the system. Contact this office at least three (3) working days in advance to arrange an inspection.
- After a successful inspection, a Notice of Approval will be issued to the owner within approximately five working days.
- Re-inspection If a re-inspection is required the fee is \$65.00 for a residential site and \$125.00 for a commercial site.

### Fees:

Single Family Residential Site: \$175.00 - Commercial Site: \$250.00 Residential Site Re-inspection: \$65.00 - Commercial Site Re-inspection: \$125.00

Note: All fees shall be paid by personal check, cashier's check or money order and should be made payable to Goliad County. No cash will be accepted.

## **PUBLIC NOTICE**

### RE: Maintenance, Testing and Routine Service for Aerobic Septic Systems in Goliad County

To The Residents of Goliad County:

At a meeting of the County Commissioners' Court on February 9, 2009, the Court accepted the State of Texas' standards to allow homeowners in Goliad County to maintain their aerobic septic systems after the initial two year maintenance contract with a licensed sanitarian has expired. The following are guidelines that must be followed in order for a homeowner to maintain an aerobic treatment system:

- Must receive training prior to doing your own maintenance inspections.
- Three inspections should be performed (at least one every four months) over a one year period and reported on the **Aerobic Septic System Inspection Report** (attached) that can be obtained in the County Judge's office or on the County web site under Public Notices.
- During inspection, any component found not functioning should be repaired or replaced.
- An effluent quality inspection consisting of a visual check for color, turbidity, scum overflow and examination for odors.
- A test for chlorine residual and pH should be taken and reported. Maintaining the chlorine tables and/or liquid chlorine bleach correctly is the homeowner's responsibility. The chlorine tube must contain chlorine tables and/or liquid chlorine bleach in a proper operating condition at all times.

Failure to maintain your aerobic septic system properly can result in failure, which can lead to expensive repairs as well as damage to the environment.
