






RHMOC Cases By Sex





Cumulative Reported RHMOC Cases by Event Date




Daily Reported RHMOC Cases by Event Date








TxS2 Percentage of ILI Visits in Region 8 this Week





Percentage of Visits Due to influenza-like Illness Reported by Texas ILINet Participants, 2017-2021 Seasons




















Data Definitions & Resources

Zavala County



RHMOC COVID-19 cases include all COVID-19 investigations not performed by the following counties: Bexar, Comal, DeWitt, Goliad, LaSalle, Maverick, Val Verde, and Victoria.

The event date for a COVID-19 case is prioritized as the first available of: symptom onset date, specimen collection date, lab result date, date reported to public health.

Region 8 reports COVID-19 recovery counts estimated as 14 days from the date of symptom onset, specimen collection, or the date when the positive result was reported to public health.

Region 8's TDCJ inmate, ICE detainee, and other correctional facility inmate counts are currently differentiated on our Cases at a Glance table and are not included in the county level data presented in this report. COVID-positive employees reported from these facilities are still counted in their county of residence. TDCJ inmate cases are investigated separately by TDCJ and are reported on the TDCJ COVID-19 dashboard. The TDCJ counts reported on the Region 8 table come directly from their dashboard and are subject to change.

The pending investigation column represents cases for which a lab result has been received but is still under verification for residency and/or case investigation. The number in this column will be added to the overall case counts for each county to reflect total reported cases. Case counts may fluctuate pending completion of investigations.

The flu surveillance data in this report is compiled from weekly reports submitted by flu surveillance partners throughout Region 8 and records submitted to TxS2 (Texas Syndromic Surveillance). TxS2 data is collected from participating emergency departments that submit data daily.
