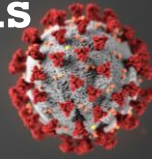

DSHS Adopts CDC/CSTE COVID-19 Case Definitions

The Texas Department of State Health Services (DSHS) adopted the updated Centers for Disease Control and Prevention (CDC)/Council of State and Territorial Epidemiologists (CSTE) COVID-19 case definitions on Sunday, November 1, 2020. The new case definitions are described in a CSTE position statement that can be found on the CDC website:

The statewide contact tracing system, Texas Health Trace, and the Region 8 RHMOC are using these case definitions as of November 1. Cases will be categorized using the new case definitions moving forward, but cases already investigated **will not** be recategorized. Previous case counts that have been reported by the Region 8 RHMOC will not change as a result of the new case definitions.

Some of the case definition updates include:

- A case may meet probable criteria if they have a positive antigen test from a respiratory specimen, even if they are asymptomatic or they do not have an exposure in the past 14 days
- The symptoms associated with likely COVID-19 infection have been updated based on data received from previous investigations.

November Is American Diabetes Month

November is American Diabetes Month. Did you know that nearly 15% of all adults in Texas have diabetes? That's 2.84 million people who have this serious, underlying health condition.

Diabetes is a chronic health condition in which the body either does not make enough insulin or cannot use insulin, causing high blood sugar levels. - In Type 1 diabetes the body does not produce insulin.
- Type 2 diabetes is when the body doesn't use insulin well and can't keep blood sugar at normal levels. This is the more common type of diabetes.

You may be able to prevent or delay your risk for type 2 diabetes by making healthy lifestyle choices, such as eating healthfully, being physically active, quitting smoking and monitoring your blood pressure. Assess your risk with The American Diabetes Association [Risk Test](#).

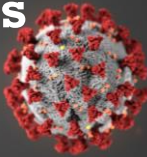
