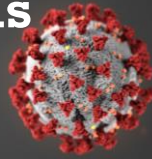

### Transmission of SARS-CoV-2 Infections in Households

The Centers for Disease Control and Prevention (CDC) in its October 30 Morbidity and Mortality Weekly Report (MMWR) discusses the transmission of SARS-CoV-2 in households based on information collected in Tennessee and Wisconsin.

Transmission of SARS-CoV-2 occurs within households; however, transmission estimates vary widely and the data on transmission from children are limited. Findings from a prospective household study with intensive daily observation for at least 7 consecutive days indicate that transmission of SARS-CoV-2 among household members was frequent from either children or adults. Household transmission of SARS-CoV-2 is common and occurs early after illness onset. People should isolate immediately at the onset of COVID-like symptoms, at the time of testing as a result of a high risk exposure, or at the time of a positive test result, whichever comes first. All household members, including the index (initial) case, should wear masks within shared spaces in the household.

Improved understanding of the transmission of SARS-CoV-2 within households could aid control measures. The findings presented in this report suggest that transmission of SARS-CoV-2 within households is high, occurs quickly, and can originate from both children and adults. Prompt adoption of disease control measures, including isolating at home, appropriate quarantine of household contacts, and all household members wearing a mask in shared spaces, can reduce the probability of household transmission. ### Cruise Ship Travel Update

The Centers for Disease Control and Prevention (CDC) has issued a news release about travelling by cruise ship. They announce that recent outbreaks on cruise ships overseas provide current evidence that cruise ship travel facilitates and amplifies transmission of COVID-19—even when ships sail at reduced passenger capacities—and would likely spread the disease into U.S. communities if passenger operations were to resume in the United States without public health oversight. Additionally CDC has announced that as of October 30, they will take a phased approach to resuming cruise ship passenger operations. The initial phases will consist of testing and additional safeguards for crew members. CDC will ensure cruise ship operators have adequate health and safety protections for crew while they build onboard laboratory capacity to test crew and future passengers. Subsequent phases included simulated (mock) voyages, certification for ships that meet specific requirements and return to passenger voyages in a manner that mitigates COVID-19 risk to passengers, crew and communities. <https://www.cdc.gov/coronavirus/2019-ncov/travelers/cruise-ship/what-cdc-is-doing.html>

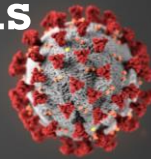
