

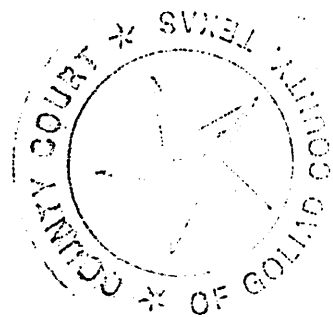

- Goliad County Transfer Station- Windscreens \$863.60



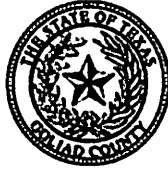
