

ORDINANCE NO. O –1515

AN ORDINANCE OF THE BOARD OF DIRECTORS OF THE SAN ANTONIO RIVER AUTHORITY DECLARING THE UNOPPOSED CANDIDATES FOR THE OFFICE OF DIRECTOR FROM BEXAR COUNTY AT LARGE, BEXAR COUNTY DISTRICT ONE, BEXAR COUNTY DISTRICT TWO, WILSON COUNTY, KARNES COUNTY AND GOLIAD COUNTY ELECTED TO OFFICE

PREAMBLE

WHEREAS, the Secretary, being the authority responsible for having the official ballot prepared for the November 4, 2025 election, has certified to the Board that the candidates whose names are to appear on the ballot for election to the Board from Bexar County at large, Bexar County District One, Bexar County District Two, Wilson County, Karnes County, and Goliad County are unopposed, that no candidate's name is to be placed on a list of write-in candidates for the office of Director from said counties, and that filing deadlines for placement on the ballot and list of write-in candidates have passed, a true and correct copy of which certificate is attached hereto as Attachment A and incorporated herein by reference; and

WHEREAS, the Texas Election Code provides that on receipt of such certification this Board may, by ordinance, declare the unopposed candidates elected to the office of Director.

NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF DIRECTORS OF THE SAN ANTONIO RIVER AUTHORITY THAT:

1. The following named candidates for the office of Director, San Antonio River Authority, being unopposed, are declared elected to said office from Bexar County Districts One and Two, Bexar County at large, Wilson, Karnes and Goliad counties:

2. The foregoing candidates having been declared elected, the election heretofore called for on November 4, 2025, to elect one Director each from Bexar County at large, Bexar County District One, Bexar County District Two, Wilson County, Karnes County, and Goliad County shall not be held in said counties and districts. A copy of this Ordinance shall be posted on Election Day at each polling place in said counties and districts that would have been used in the election.
