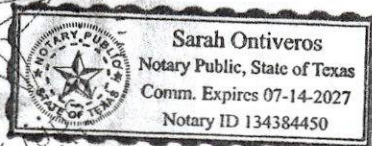
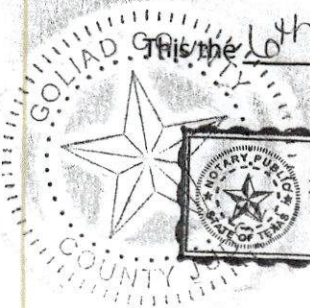

ESTRAY FORM OFFICER CHECKLIST

Date: 4/4/26

ZG 1. **Prior to impounding Estray:** Contact Supervisor/Dispatch make sure all possible owners' are contacted.

ZG a. **Get approval** to contact livestock officer or County Cowboy for impound.

ZG 2. **Take photos of the animal** and note any distinct characteristics or identifiers (livestock officer should help with breed, weight, age etc.)

ZG 3. **Fill out Estray Form** (this will help with getting all the correct information).

ZG 4. **File RMS Documentation** (should be a brief narrative "titled ESTRAY LIVESTOCK" also attach all images of the animal to RMS).

ZG 5. **Retrieve Call Sheet From Dispatch** (Dispatchers should list all attempted contacts/owners in Call Notes).

ZG 6. **Turn in completed packet to Sgt. Or Officer in charge of Estrays**

a. *Packet should contain in order:*

(1) *Completed Check-List*

(2) *Call Sheet*

(3) *Estray Sheet*

(4) *Officer Narrative*

(5) *Photos*

(6) *Copy of Posted notice*
