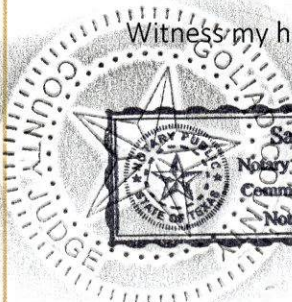

ESTRAY FORM OFFICER CHECKLIST

Date: 4/17/24

1. **Prior to impounding Estray:** Contact Supervisor/Dispatch make sure all possible owners' are contacted.
- a. **Get approval** to contact livestock officer or County Cowboy for impound.
2. **Take photos of the animal** and note any distinct characteristics or identifiers (livestock officer should help with breed, weight, age etc.)
3. **Fill out Estray Form** (this will help with getting all the correct information).
4. **File RMS Documentation** (should be a brief narrative "titled ESTRAY LIVESTOCK" also attach all images of the animal to RMS).
5. **Retrieve Call Sheet From Dispatch** (Dispatchers should list all attempted contacts/owners in Call Notes).
6. **Turn in completed packet to Sgt. Or Officer in charge of Estrays**
- a. *Packet should contain in order:*
- (1) Completed Check-List
 - (2) Call Sheet
 - (3) Estray Sheet
 - (4) Officer Narrative
 - (5) Photos
